## **Mental Illness Awareness Week/Bipolar Disorder Awareness Day October 7-13, 2007**

## MEET THE STAFF: Program Coordinator Chris Novak



How do I sign up for Family to Family classes? When is there a Care and Share support group in my area? How can I get help for myself and for my loved one? If you have called the NAMI Ventura County phone number and asked these questions in the past eighteen months, chances are you've talked to Program Coordinator Chris Novak.

Since joining the NAMI team in February, 2006, Chris has answered an average of five phone calls per day and has been the first point of contact for most folks who have called NAMI in the past year and a half.

Additionally, Chris is Ventura County's "go-to" person for coordinating Family to Family classes, securing locations, distributing flyers, handling publicity and taking registration for Family to Family participants. Chris provides binders and materials for all the classes and collects end-of-class evaluations and volunteer forms. She also collects and formats membership data, and recently coordinated Care and Share facilitator training, sponsored by NAMI Ventura County.

Novak explained, "I love meeting and working with the people involved in NAMI because they're very passionate about their work and the organization." Chris played a key role in this year's NAMI Walks for the Mind of America, assisting walk manager Debbie Hurt at the Kick-Off Luncheon, and working behind the scenes to secure donations for walk day, where the entire Novak family pitched in as volunteers.

Novak, herself, has strong ties and a long history as a Ventura County resident, having first lived in the County from 1969 to 1975 and then returning in 1978 to the present. She and her husband Joe have been active in the Ventura County community, raising their two children, Tiffany – now 24, and Shane – 21. In addition to her NAMI work, Chris works as a travel agent for Friendship Cruises and Tours, and with her husband Joe manages and owns Channel Islands Plumbing.

Chris enjoys working at the new NAMI office in Camarillo, where all program data and materials are centrally located and easily accessible.❖

## TREATMENT-LIMITING SYMPTOMS David Gudeman, M.D.



NAMI Ventura County's General Meeting on 11th July featured Dr. David Gudeman, a well-known local psychiatrist. Dr. Gudeman gave a stimulating presentation on the reasons why treatment of the mentally ill is so difficult.

He began by drawing a picture of a house, equating the three components to a treatment regimen: Biology as the foundation may include medications. Psychology was the outer walls, indicating a need for psychotherapy. Sociology was the roof, showing the need to integrate into society. Consumers need all three components to move into recovery. The general population will support helping the physically and mentally handicapped, or children with mental disorders. But when it comes to mental illness, stigma & fear keep people from seeking and getting treatment.

Dr. Gudeman explained that in mental illness, the brain and the cortex are not working correctly in three different ways. In the first instance, the mind has too much function, and may add information, for example in the form of auditory hallucinations. In the second, the mind has less function and may enter a depressed state. In the third instance, the mind is disorganized, leading to a lack of cognition.

What would a good society do to help the mentally ill? Instead of stigmatizing and fearing, Dr. Gudeman was clear that such a society would intervene aggressively. This might include hospitalization and medications against their will, just to be able to get them to recognize that there was a mental disorder. Several family members gave their own examples to show agreement with Dr. Gudeman.

The Board of NAMI Ventura County has recently added Dr. David Gudeman to its Advisory Panel and looks forward to an ongoing relationship with him.❖

## STATE TRAINER COMES TO VENTURA COUNTY

NAMI California's Program Director, Lynn Cathy, came to Ventura County in July for an intensive 20-hour facilitator training. Lynn, assisted by Glendale NAMI board president, Jonee Shady, trained nine Ventura County NAMI members and fourteen participants from NAMI Santa Barbara, Glendale, Manhattan Beach, Los Angeles and San Gabriel Valley as Care and Share support group facilitators.



During the training, which was sponsored by NAMI Ventura County, facilitator trainees were divided into two groups and then led through a NAMI support group "model". Participants were asked to "role play" in several different scenarios, to help them become familiar with the Principles of Support:

- WE WILL SEE THE INDIVIDUAL FIRST, NOT THE ILLNESS.
- WE RECOGNIZE MENTAL ILLNESSES ARE BRAIN DISORDERS.
- WE AIM FOR BETTER COPING SKILLS.
- WE FIND STRENGTH IN SHARING EXPERIENCES.
- WE REJECT STIGMA IN OURSELVES AND OTHERS.
- WE WON'T JUDGE ANYONE'S PAIN AS LESS THAN OUR OWN.
- WE FORGIVE OURSELVES AND REJECT GUILT.
- WE EMBRACE HUMOR AS HEALTHY.
- WE ACCEPT WE CANNOT RESOLVE ALL PROBLEMS.
- WE EXPECT A BETTER FUTURE IN A REALISTIC WAY.
- WE WILL NEVER GIVE UP HOPE.

Each participant had the opportunity to lead a support group session. Among the new trainees in Ventura County were Nina Bhavnani – who will be leading the Care and Share Support Group in Camarillo, Sally Kosoff and Kira Sutton – who will be co-leading the Care and Share Support Group in Ventura, which is now meeting on a twice monthly basis, Lou and Lynn Gates, and Connie Hall. ❖

## NAMI HONORS "CANVAS"

At its annual convention in San Diego, NAMI honored the film "Canvas", with an "Outstanding Media Award" for a dramatic motion picture. The film, which is scheduled to be released October 12, stars actress Marcia Gay Harden, actors Joe Pantoliano and Devon Gearhart, and was directed and written by Joseph Greco.

Academy Award winner Marcia Harden plays Mary Marino, a mother who becomes ill with schizophrenia. Emmy Award winner Pantoliano plays her husband, John Marino.

The movie is inspired by a true story and the award by NAMI praised the film for its "accurate, balanced, and compassionate" portrayal of a family transformed by mental illness.

"Canvas is marked by intense, tragic emotions, touches of humor and an enduring spirit of hope," said NAMI executive director Michael Fitzpatrick. "It is one of the few films that is authentic in its portrayal of schizophrenia. It has the potential to touch the general public even more than the movie *A Beautiful Mind*, because it focuses on the experience of an average family, rather than that of a Nobel Prize winning mathematician. ## **PROVIDER EDUCATION HITS GROUND RUNNING**

In July, NAMI brought the first Provider Education Program training class to Ventura County. Meeting together for ten weeks at the Interface Community Room in Camarillo, mental health workers from a variety of perspectives – housing, hospice, jail, private practice – have heard about mental illness from the family and consumers’ perspectives. One MFT intern’s response summed it up for the group, “I’ve taken lots of classes in the internship program, but this is by far the best. I actually look forward to coming to this class.” The class, which is free and applicable to all who serve those with serious mental illnesses, is funded through a grant from the Mental Health Services Act. ## **LITHIUM HELPS BRAIN AND MOOD**

The *Journal Watch Psychiatry*, August 13, 2007 issue reports that in bipolar patients, lithium seems to increase gray matter in areas that regulate mood and cognition. Mood disorders are associated with brain-volume loss, which may be related to neurotoxicity. To determine whether lithium might protect against the neurotoxicity of chronic bipolar disorder, researchers used MRI to compare gray-matter density in outpatients with bipolar disorder and health controls.

The bipolar group had significantly larger gray-matter volumes than the control group did, and this difference was entirely explained by the 9% greater gray-matter volumes in the frontal, parietal and temporal lobes of the lithium-treated group. Gray-matter volumes were similar between controls and patients not taking lithium.

The largest difference in gray-matter volumes occurred in areas that regulate mood or cognition. Lithium might help to correct the structure and function of systems that work poorly in mood disorders. Considering similar findings from other studies (e.g., *Journal Watch Psychiatry*, February 8, 2006), there may be reason for the bipolar patient to continue taking lithium to protect the brain as well as his or her mood.

## ATTENTION: PAXIL CLASS ACTION SETTLEMENT

There has been a national settlement in a lawsuit that alleged that the company GlaxoSmithKline concealed information about the safety and effectiveness of prescribing Paxil for children. Anyone that purchased Paxil or PaxilCR/TM for a minor child is entitled to recover as much as 100% of their documented out-of-pocket costs. A claim form must be received by 8/31/07.
