Dear Chair Sanders, Ranking Member Cassidy, Chair McMorris Rogers and Ranking Member Pallone,

On behalf of the 71 following organizations representing consumers, families, mental health and addiction providers, advocates and other stakeholders committed to strengthening access to highquality mental and behavioral health care, we write to urge you to include the bipartisan Kid Providing Resources for Optimal Outcomes Against Fatalities (Kid PROOF) Act, in the final reauthorization of the Substance Use-Disorder Prevention that Promotes Opioid Recovery and Treatment (SUPPORT) for Patients and Communities Act. Kid PROOF will give parents needed support and save young lives from the tragedy of suicide and overdose.

The Kid PROOF Act is led by Senator Lujan (D-NM), Senator Rubio (R-FL), Representative Craig (D-MN), and Representative Tony Gonzales (R-TX).

Recent CDC data from the Youth Risk Behavior Surveillance System shows an alarming increase in high school students who report having persistent feelings of sadness and hopelessness, poor mental health, and serious thoughts of suicide.<sup>1</sup> Additionally, the rate of overdose deaths among U.S. teenagers nearly doubled in 2020 and continued to rise by another 20 percent in the first half of 2021 compared with the 10 years before the pandemic.<sup>2</sup> We must act now to address these alarming statistics and support parents everywhere in need of solutions for their children.

Kid PROOF will provide grants for states to partner with health care providers through the Substance Abuse and Mental Health Services Administration (SAMHSA) to provide supplies to parents, with their consent, when a child is at risk of suicide or overdose. This is an evidence-based approach to put away dangerous items when a child is considering suicide or overdose, for example, medications such as opioids. The Kid PROOF Act will provide parents with immediate support to help their child avoid making a tragic decision.<sup>3</sup>

Evidence has shown that 95 percent of individuals do not go on to die by suicide when items are stored and 90 percent of parents will utilize supplies when given to them.<sup>4,5</sup> The use of supplies to store opioids and items dangerous to children is encouraged by national groups including the American Medical Association, the American Foundation for Suicide Prevention, and the American Academy of Family Physicians.<sup>6,7</sup> **Kid PROOF is the solution to help keep kids safe from suicide and overdose.** 

We applaud the Senate Health, Education, Labor, and Pension Committee (HELP) for working in a bipartisan manner to include the Kid PROOF Act in the reauthorization of the SUPPORT Act that passed out of Committee in December of 2023. We urge you to ensure that Kid PROOF is included in the final reauthorization of the SUPPORT Act. The Kid PROOF Act will protect the most vulnerable in our society as providers, parents, and communities continue to respond to the youth mental health and substance use disorder crisis.
